Bert Pickell motioned and Lawrence Jackson seconded to approve the October 9, 2024 meeting minutes. The motion passed unanimously.



4. Discussion and Appropriate Action on Active Transportation Advisory Committee Bylaws Updates – AAMPO (Moreno)
